

Off Licence (For Premises)

Licence no: 15/OFF/01399/2026

Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Harsukh Trading Limited** is authorised to sell alcohol on the premises situated at 529 Te Rapa Road Te Rapa Hamilton 3200, Hamilton and known as “**Super Liquor Te Rapa**”, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises. The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else. The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with the Act.

CONDITIONS: This licence is subject to the following conditions:

- (a) Alcohol may be sold only on the following days and during the following hours:
Monday to Sunday, from 9:30am to 9:30pm.
- (b) No alcohol is to be sold on the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (c) Single sales of alcoholic products priced at less than \$6.00 per unit are prohibited.
- (d) Sales of energy drinks combined with an alcohol content of 7% or higher in containers of 1 litre or more are prohibited.
- (e) The use of ‘buy now, pay later’ payment options is prohibited.
- (f) There is to be no external advertising of alcohol products or pricing.
- (g) The area where alcohol is to be sold is described in the plan date stamped as received by District Licensing Committee on 25 February 2026.
- (h) The entire premises is designated as a supervised area (no persons under 18 can be in the area unless with their parent or legal guardian).
- (i) A properly appointed certificated, acting or temporary manager must be on duty and on the premises at all times when the premises is open for the sale and supply of alcohol.
- (j) A manager’s register (as required by s.232 of the Act) is to be maintained and available on site.
- (k) The licensee must ensure all staff receive training in their responsibilities and obligations under the Sale and Supply of Alcohol Act 2012.
- (l) There must be no sale or supply of alcohol to minors or intoxicated persons and there must be appropriate signs detailing these restrictions at every point of sale.
- (m) Drinking water must be freely available and displayed whenever alcohol is being supplied by way of complimentary tastings.
- (n) The Licensee must ensure the following are displayed;
 - i. A sign to be seen from outside the principal entrance stating the ordinary hours of business during which the premises will be open for the sale of alcohol.
 - ii. A copy of the original licence with all the conditions, just inside the principal entrance so persons entering can read it.
 - iii. A sign in a prominent place identifying the duty manager.
 - iv. An A4-sized sign warning about the dangers of alcohol in pregnancy must be clearly displayed at every point of sale and health promotion pamphlets must be available in store offering advice on reducing alcohol harm.

Remote Sale Conditions:

- (o) Alcohol may be sold remotely at any time, on any day.
- (p) Alcohol sold remotely must not be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day, and must not be dispatched from the store for delivery between 8:00pm and 6:00am the following day.
- (q) The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the receiver (where present) is not intoxicated.
- (r) The outside of the delivery package must contain a label with the following words: CONTAINS ALCOHOL - Do not deliver to intoxicated persons.
- (s) A copy of the licence must be displayed on the Super Liquor internet site in a prominent place.

Subject to the requirements of the Act relating to the payment of fees, and to provisions of the Act relating to the suspension and cancellation of licences, the licence expires on:

26th day of March 2029

OR, until the close of the period in which this licence is subsequently renewed.
